Get your Tax Certificates Online or at Convenience Stores

Method 1

Online Application * Credit card required.



- No need to go to a counter.
- Requests for certificates can be made online 24 hours a day, 7 days a week.
- Fee: 300 yen per copy*+ Postage: 84 yen (flat rate).
- Certificates are sent by mail approximately 3 business days after receipt of application.

* Tax certificates (or tax exemption certificates) for individual inhabitant taxes are issued per fiscal year.

* Tax payment certificates are issued per ward and per tax category.

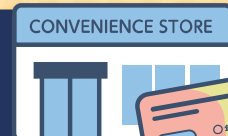


Tax payment certificates



Method 2

Convenience Store Issuance Service * My Number Card required.



- If you have a My Number Card, certificates can be issued at Multipurpose machines at most convenience stores.
- Fee : 150 yen per copy; half the price of when issued at a government office counter.

* You must be a registered resident of Kobe City for the entire period from January 1 of the year you wish to obtain a certificate for to the date of issuance.

* Available only for tax certificates (or tax exemption certificates) for individual inhabitant taxes(Unavailable for tax payment certificates).

* Only certificates for the current and previous fiscal year can be issued.
